Bridge Construction Notification

Construction will be taking place at SW 31-35-05-W5M, on local road Township Road 6-0, approximately 6 km south of Caroline, in between Township Road 36-0 and Township Road 35-4. The bridge culvert is crossing Beaver Creek. Construction is scheduled to begin on Wednesday, August 15th and scheduled completion on September 15th, 2018, weather dependent. During this time, the road will be closed and with a detour in place.

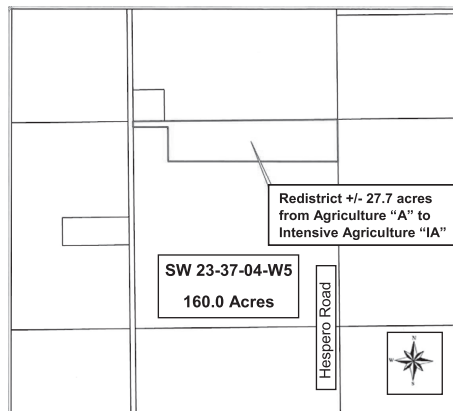
A Public Hearing will be held on Tuesday, August 28, 2018, 9:00 am at Clearwater County Council Chambers.
