ROADSIDE CLEANUP ON MAY 12, 2018

In May of each year Clearwater County sponsors a Roadside Cleanup Campaign. Benefits of the campaign include:

- Contributes to a cleaner environment
- Teaches participants to appreciate their environment
- Gives participants a sense of accomplishment
- Promotes awareness of club or group
- Raises funds for club or group activities

This program is intended for youth and community groups and involves cleaning a section of road right-of-way (ditch) in Clearwater County. Each community group receives \$600.00 per section cleaned – this year there will 38 road sections available on a first-come, first-served basis.

The map outlining the sections will be posted on the County's website under the Agriculture and Community Services department beginning April 16, 2018.

Registration for route/section selections will take place ONLINE beginning April 30, 2018, at 8:00 a.m. Applicants are asked to indicate first, second, third and fourth choices for road sections. Once routes/sections are assigned, the "group contact" will be advised of section allotment and coordinate material pickup and contract signing. Traditional in-person sign-up will be available after May 1, should there still be routes available.

Safety vests, gloves, garbage bags and signs are provided by Clearwater County.
